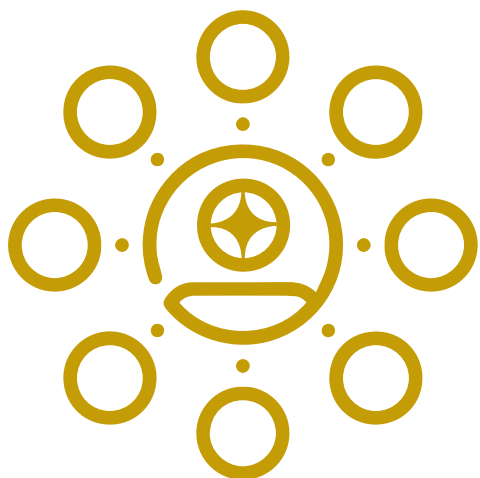

OAS Security Certification: The corresponding security requirements must be met according to the position and activity within the import/export logistics chain and the corresponding manuals must be provided for:

1. Safety of business partners.
2. Security of container and other cargo units.
3. Physical security of facilities.
4. Personnel security.
5. Security for People access to facilities.
6. Product Security.
7. Training of personnel in security, and both internal and external threats to the company.
8. Logistics chain planning.
9. Information security and protection.
10. Risk matrix: In addition to the manuals, the supply chain risk matrix must be provided in order to **identify, analyze and assess threats, developing a plan and measures to mitigate them.**
